


ORDERS as follows:

1. Conferences with the Discovery Master and liaison counsel will be held in the offices of The Dispute Resolution Institute on the following dates and times:
 - a. Thursday, March 18, 2010 – 9:00 a.m. (one-half day)
 - b. Thursday, March 25, 2010 – 9:00 a.m. (one-half day)
 - c. Wednesday, April 7, 2010 – 10:00 a.m. (full day)
 - d. Wednesday, April 21, 2010 – 10:00 a.m. (full day)
2. As soon as practicable prior to all conferences, counsel shall submit to the Discovery Master a specific agenda regarding issues to be addressed at the conference. Counsel shall endeavor to agree upon such agenda.
3. Counsel shall also provide to the Discovery Master a writing which details their respective positions with respect to agenda items.
4. Any and all submissions to the Discovery Master shall be made either by hand-

5. Any and all requests for relief of any nature whatsoever regarding discovery issues may be submitted, at the option of the movant, to the Discovery Master in letter format in lieu of a formal motion.
