DISCOVERY MASTER ORDER NO. 8

AND NOW, to wit, this 1st day of June, 2010, following an extended conference with counsel on May 26, 2010 the Court-appointed Discovery Master, Harris T. Bock, Esquire, hereby **ORDERS** as follows:


1. The next conference with the Discovery Master and all counsel electing to participate will be held **all day on Tuesday, June 8, 2010 commencing at 9:30 a.m.**, at Golkow Technologies, One Liberty Place, 1650 Market Street, Suite 5150, Philadelphia, Pennsylvania, 19103.
2. **Hassett v. Dafoe (CMO #7)**: The Discovery Master met with Judge Moss on May 27, 2010 and presented to the Court the CMO agreed upon by counsel at the May 26, 2010 conference. Judge Moss reluctantly agreed to extend the trial ready date to May 16, 2011. CMO #7 should be promptly finalized to reflect the foregoing.
3. **CMO #8**: Counsel shall continue to meet and confer to finalize the language for CMO No. 8, including the “authorization exhibits” to be attached thereto.

4. **Foreign Regulatory Matters:** Upon the request of DLC, the Discovery Master is extending the deadline to submit the previously requested information to the close of business on Monday, June 7, 2010.
5. **Prior Expert Reports:** Consistent with Paragraph 5 of Discovery Master Order No. 6, the production of prior expert reports and transcripts shall be made contemporaneously with the production of documents responsive to the Master Requests for Production. All responsive expert reports and transcripts in the custody, control, and possession of defendants' counsel shall be deemed to be in the custody, control, and possession of defendants.
6. **Document Production Protocol:** Counsel shall continue to meet and confer to finalize the document production protocol language for CMO No. 9.
7. **Preservation Order:** This will be an agenda item for the June 8, 2010 conference.
8. **Requests for Production:** Upon the resolution of the foreign regulatory issues at the June 8, 2010 conference, the Master Requests for Production should be finalized and served on defendants within ten (10) days thereafter.
9. **Pre-Meeting with MCS Representative:** A representative from MCS will attend the June 8, 2010 conference. Counsel shall meet and/or confer with the appropriate MCS representative in advance of the upcoming conference to provide the representative with a list of questions and/or issues to be addressed at the conference.
10. Further conferences with the Discovery Master and all counsel electing to participate will be held all day on Monday, July 26, 2010, commencing at 10:00 a.m. and Tuesday, August 17, 2010, commencing at 9:30 a.m. (if needed), the

locations for which are to be determined.

11. As soon as practicable, counsel shall submit to the Discovery Master a specific agenda regarding issues to be addressed at the June 8, 2010 conference, along with any supporting materials for the Discovery Master to review prior to the conference.
